III. OFFICE OF THE TRUST :-



IV. That the area of operation of the Trust will be throughout India. It can open offices anywhere in India and carry out the planned activities anywhere in India. The Trust has an All India character.


V. That the objects for which this is established are :-


2. 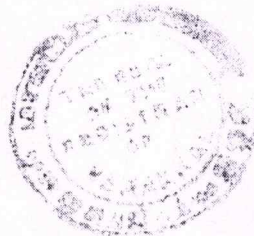

- 11. - 12. - 14. The Trust will help the students for their education in Graduate and Postgraduate levels. The Trust will help the Graduates, post Graduates and technically qualified persons in getting suitable jobs in private and government organizations.

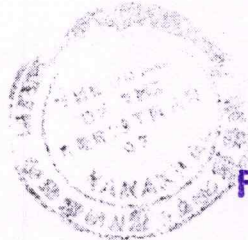

15. To help the students, self-employed persons in getting loans for education and other necessary assistance for furtherance of studies.
16. To run old age home for aged persons and for Widow women
17. To run orphanage for children those who lost their parents in natural disaster and the children those who are abandoned by their parents.
18. To give donation to other trust(s) carrying on similar objects.
19. To establish, develop, maintain and grant aid in cash or in kind to hospitals, medical schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centre and/or such other similar charitable institutions in India for the benefit and use of the general public.
20. To do such other things/acts/activities which are necessary and which may be incidental or ancillary to the achievement of any of the above stated objects.

VI. BOARD OF THE TRUSTEES:-

- a. There shall be constituted a Board of Trustees for the management of the TRUST which will be hereafter referred to as the "Board". The Founder of the Trust will be the Managing Trustee of the trust during his life time and his successor will be appointed by the Board as Managing Trustee with approval from the board. The Founder of the Trust hereby affirms the other persons of the Board (besides himself), who constitute the Board of Trustees at the time of execution of the Trust and who will be referred to as the Trustees. 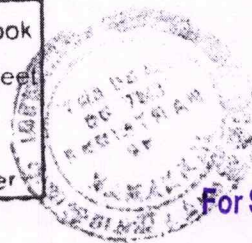

- b. The Board of Trustees shall have power to nominate one or more trustee(s) after Consulting with Managing Trustee and with approval from the board.
- c. The Board of Trustees shall have power to nominate office bearers and other committee members among the trustees, to facilitate administration of the trust after consulting with Managing Trustee and with approval from the board.
- d. It is hereby expressly declared that no portion of the Trust funds shall be directly or indirectly spent to benefit either the Founder /Managing Trustee of the Trust or any other Trustees except for the purpose of execution of the activities to realize the aims of the Trust. All the income, earnings, movable or immovable properties of the Trust shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the Memorandum of Association and the same shall be managed by the Managing Trustee who is the Founder of this Trust for promoting the aims and objectives of the Trust.
- e. The Founder cum Managing Trustee shall hold office at his pleasure and on the vacation of office, the Founder herein on his/her own violation or by death or otherwise the remaining Trustees herein shall appoint the legal heirs of the deceased subject to the condition of Clause IV(b).

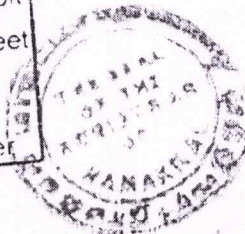

VII. TERMINATION OF TRUSTEES:-

- a. The Managing Trustees shall not be terminated unless:-
 - 1) on his death;
 - 2) by his voluntary resignation.
- b. The ordinary Trustees shall cease to be Trustees in case of:-
 - 1) his/her death;
 - 2) by his voluntary resignation.

VIII. POWERS OF THE PRESIDENT:-

Founder cum Managing Trustee will act as a President of the Trust

The President of the Trust shall be Executive Head of the Trust. His advice shall be final in all matters pertaining to the administration of the Trust. He shall preside over all meetings; conduct the meetings in a democratic manner. The President of the Trust is the head who will be the Chief Administrator and the President will appoint other office bearers if necessary after discussing with Managing trustee

IX. POWER OF THE MANAGING TRUSTEES:

- b. Managing Trustee has to control the entire affairs of the Trust to smooth functioning of the Trust and to achieve the object of the Trust.
- c. Managing Trustee has the power to interact with state, central authorities and any other local bodies, Association of persons, authorities or other individual for the purpose of obtaining financial and technical aid or assistance on such terms and in such form as they deem fit for the furtherance for the purpose and object of the trust.
- d. Managing Trustee has the power to appoint the auditor of the trust, after consulting with board of trustees.

- e. The Managing Trustee after discussing with all the trustees, has the power to remove from the power or dismiss the Treasurer, Secretary and any other board of trustees or members if they act against the object of the trust or act illegal manner. He/She should be expelled from the trust by the managing Trustee provided the Managing trustee has to get approval from the board.
- f. To elect any trustees to do or discharge the administrative functions or works for the benefit of the trust.
- g. Managing Trustee shall have the power to appoint such staff, assistants and employees on such remuneration as they may deem fit in the administration of the trust after consulting with Board of the Trustees.
- h. Managing Trustee has the power to constitute committees consisting of one or more trustee or SETTLORS or DONER for such period after discuss with board of trustees may from time to time decide upon for obtaining aid and advice in carrying out the objects of the Trust.
- i. Managing Trustee after consultation with Board of trustees shall constitute a Governing Council for each of the college/School or institution run by the trust in accordance with the Rules for the time being in force. The Function of such Governing Council shall be only advisory on matter relating to the organization management and administration of the institutions.
- j. Managing trustee has the power to constitute as many sub committees as may be necessary or expedient from time to time for management of the various institution come under the trust.

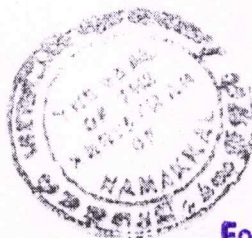


- k.** To open account in the name of the Trust and/or Institutions run/conducted by the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees

- n.** To acquire by all lawful mean movable and immovable properties on behalf of the trust and to all, Manage, Mortgage, Lease or exchange, Dispose of or otherwise deal with all or any of its properties and income there from and with approval from the board.

X. POWERS OF THE SECRETARY/JOINT SECRETARY:-



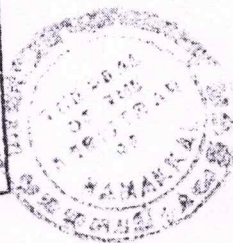



- a. She/he is empowered to be present before authorize to give written Petition, to correspond to maintain registers, files, etc., of the Trust to regularize the aims, plans and activities of the Trust.
- b. He / She is also empowered to convene Trust Board Meetings, to set up office, to maintain registers, files, etc., of the Trust, to regularize the aims, plans and activities of Trust after getting formal confirmation from Managing Trustee

XI POWERS OF THE TREASURER:-

- a) He / She will be in charge of the accounts, and receipts for the amount in his custody, get the authorization of the Board of the trust for the disbursements of money, maintain the accounts, and arrange for the audit of the accounts
- b) The Trust's Treasurer can keep the money of the Trust with him up to a limit of Rs.50,000/- in order to meet the incidental expenses to be incurred for the purpose of Trust.
- c) To arrange the books of accounts for the audit of the accounts for
Income tax filing and other compliance.

XII POWERS OF THE BOARD:-


The Board of Trustees shall have the following powers viz:


1. To frame Rules and Regulations for the conduct and management of the Trust time-to-time including determination of the amount it shall collect as donations and subscriptions from the Trustees and the amount which shall be spent;
2. To expend or utilize the Trust funds exclusively for Trust objects not for purpose of profit and carry out and implement the objectives of the Trust by delegating responsibilities to paid staff or jointly.
3. To invest the corpus or any funds donated to the Trust at their discretion in any useful areas subject to the provisions of the Income Tax Law;

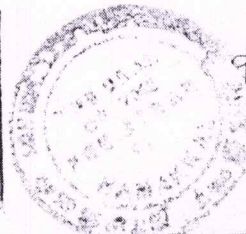

4. To apply for and obtain grant-in-aids and accept contributions/donations in money or in the shape of property from any donor agencies both Government and private agencies in India or foreign countries provided that acceptance of such donations shall not be objectionable under any of the provisions of the Income-Tax law as in force at the time of acceptance of such donations.
5. To call in and convert into cash the Trust properties and realize any or all of the securities and investments and to reinvest and/or dispose of the proceeds in such manner as is authorized herein;
6. To levy reasonable fees or charges from the beneficiaries benefiting from the establishments run by the Trust for covering the administrative costs.
7. To employ, promote and discharge managers and other staff to engage services of auditors, lawyers and other professionals in the course of administration of the Trust after getting approval from Managing Trustee.
8. To consider the progress regarding the work of the Trust and its plans for the future and review the financial status time to time.
9. To fix the date and time of the meetings;
10. To accept any donation, contribution, grant, gift or subscription in cash or in kind, from any person(s), body of persons or trust, with or without conditions.
11. To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time subject to provisions of Income Tax Act 1961
12. To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.

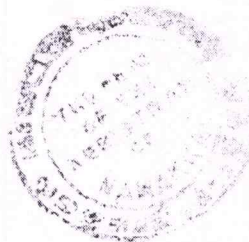

- 13. To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- 14. To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.
- 15. To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organization or Trustees to start maintain, or carry out such charitable objects.
- 16. To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- 17. To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.





20. To Purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
21. To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the trust, societies, institutions or associations with which this Trust is authorized to amalgamate.
22. The Board as such shall have power and authority jointly
 - (a) to carry out the resolutions.
 - (b) to sign papers and receipts and documents.
 - (c) to pay money due by the Trust and demand and get receipts there for after getting approval from Managing Trustee.
 - (d) to demand any money received;
 - (e) to make draw enforce, accept, sign, negotiate of transfer cheques, promissory notes, hundies, bills of exchange, railways receipts negotiable or transferable instruments, government securities or other securities;


